



Travel

- Time: 2-3 hours by Sumo/Tempo

- Arrive at the campsite, witness a stunning sunset.
- Overnight camping at Bir Billing.

PARAGLIDING ADVENTURE & TRANSFER TO TIRTHAN VALLEY

Travel

- McLeod Ganj to Bir Billing
- Distance: 160 km
- Time: 5-6 hours by Sumo/Tempo

- Early morning paragliding adventure over the majestic mountains.
- Leisure time in Bir post-paragliding.
- Depart for Tirthan Valley, with a sunset stop along the way.
- Arrive in Tirthan Valley by late evening, followed by dinner.
- Overnight stay at a hotel in Tirthan Valley.

JALORI PASS & SEROLSAR LAKE TREK

Travel

- Tirthan Valley to Jalori Pass (by vehicle)
- Distance: 30 km
- Time: 1-2 hours by Sumo/Tempo

- After breakfast, drive to Jalori Pass.
- Trek to Serolsar Lake, taking in panoramic Himalayan views.
- Return to Tirthan Valley, enjoy a bonfire and music.
- Overnight stay at a hotel in Tirthan Valley.
